Professional Trainer Jeff Schwartz will be going over how to handle, and train your dog for competing in Hunt Test for Spaniels, You will be working on running your dog in the field, retrieving on land and water, and blind retrieves on land and water. So bring your dog and problems and find some answers to your problems.

This will be a two part seminar first session starting at 8:00 A.M. for the field work, lunch break around 11:30 (provided by WESSA) sandwiches and water, afternoon session starting around 12:15 P.M.

List of things to bring with you. Blaze orange is required for out in the field, we will be shooting, water for your dog, chairs, extra beverage for yourself, bucks that you use for retrieving with your dog

We will be over by the Technical Ponds, you will make a left turn by the Observation Tower. Follow the signs please and field flags . They will be marked WESSA Hunt Test This will be open to all Flushing Spaniels. The seminar will be limited to 15 dogs. Entries will close on June 10, 2011.
